

SUMMARY OF SHOULDERING PROPOSALS FOR CLEAR LAKE ROAD

June 19, 2017

- Olynick: Based on hourly basis at the rate of \$400 per hour for shouldering machine and \$100 for wobble-wheel roller. Estimating 8 to 9 hours. Assume 9 hours at \$500 or \$4,500 plus \$8,855 for 1,150 tons of A & B-delivered gravel = \$13,355.
- A1 Excavating: Based on \$6 per ton for shouldering machine with compaction or \$6,900 plus \$8,855 for 1,150 tons of A & B-delivered gravel = \$15,755.
- Chippewa Co.: Estimated \$16,000 for shouldering and compaction equipment with stipulation that county will truck material from A & B pit. Note: County will not allow non-county trucks to back up to shouldering machine. \$16,000 plus \$5,405 for A & B supplied gravel = \$21,405
