## **Permit Provisions and Conditions of Issuance**

Pursuant to Wisconsin Statutes, this permit is granted to allow performance of the specific work described herein. The following standard provisions and any included special provisions shall govern.

I.Fee Schedule:Utility Activity<br/>First service installationFee<br/>\$75First 200 feet of run parallel to ROW centerline\$75Additional service installations\$55

Each additional 1000 feet of run parallel to ROW center line \$55

II. The Applicant agrees to indemnify and hold harmless the Permitting Authority, its employees and its agents, from any cost, claim, suit, liability and/or award which might come, be brought, or be assessed, because of the issuance or exercise of this permit, or because of any adverse effect upon any person or property which is attributed to the partially or entirely completed works of the Applicant. Accomplishment of the permitted work, or any part thereof, by or on behalf of the Applicants shall bind such Applicant to abide by this permit and all its conditions and provisions.

- III. The Applicant shall assume any and all liabilities to the town for all damages which occur during the progress of the utility work.
- IV. Vehicles, equipment and materials shall be so regulated by the Applicant as to assure consistently safe conditions. Particular care shall be exercised at all times to assure a safe traffic environment at and near the site of the work. These requirements pertain while the work operations are in active progress, as well as during periods of work shutdown. Any discovered violation of this permit may result in revocation of the permit and expulsion from the town right-of-way.
- V. The Applicant is to assure that the site of construction is secure against any hazard to the public, both when the site is attended and during off hours, any holiday, and night-time hours.
- VI. The entire cost of installing and maintaining the utility in the Town right-of-way shall be borne by the Applicant.
- VII. The depth of the utility line shall be a minimum of 30" below ground level and, in the event there is settling or other damage, the Applicant shall make the necessary repairs at its own expense in accordance with instructions given by the Town. Any utility line installed at a depth less than 30" shall be enclosed within a larger pipe, conduit, duct or casing sufficient to protect the line from external damage.
- VIII. Any dirt or debris resulting from the installation and/or maintenance of the utility line shall be removed as soon as possible from the right-of-way by the Applicant.
- IX. The Applicant shall be responsible for providing erosion control measures to protect all restored areas upon completion of the utility construction until replacement vegetation achieves sustained growth.
- X. The Applicant shall be responsible for determining the location of and protecting from damage any other utilities already in place in the area to be affected by the permitted work. All required notifications shall be the responsibility of the Applicant.
- XI. This permit authorizes only the described works of and for the Applicant named in this permit. It does not grant authority for the utility installations of any other utility.
- XII. A copy of this application/permit and related plans shall be available on the job site.
