




Rescind Resolution #1-Fire Department 1996



RESOLUTION # 1 - FIRE DEPARTMENT 1996

WHEREAS, the Town of Eagle Point, in order to efficiently and effectively operate a Fire Department, deems it necessary to impose charges upon residents of the Town, tax exempt entities within the Town and non-residents of the Town;

NOW THEREFORE, be it resolved by the Town of Eagle Point, that the rates set forth on the, "Sample billing", attached to this Resolution be charged to residents of the Town and that the maximum charge to residents of the Town shall be Five Hundred Dollars (500.00) for each, "Call", these charges shall apply only to structure fires.

BE IT FURTHER RESOLVED, that Tax Exempt Entities shall be charged the full cost of the, "Call". Said charges shall be based upon the hourly charges set forth on the, "Sample billing", attached hereto and made a part of this Resolution; and


BE IT FURTHER RESOLVED, that, "Calls" made to motor vehicle accidents and for the protection of property, of non-residents and non-property owners of the Town, as well as calls made outside of the Town, shall be charged twice the hourly rate set forth on the, "Sample billing" attached hereto and made a part of the Resolution, unless the call is covered by a Mutual Aid Agreement.


