2022 - 2023 Accomplishments

- Applied for and awarded \$412,000 in WisDOT Discretionary/Supplemental cost-sharing grant to improve 95th Avenue (Darrow Road)
- Implemented a road improvement plan that proposes 5.3 miles of repaying in 2023 and road preparation for 2024 re-paying projects
- Recognized the completion of Bloomer Telephone Company's broadband project in the town with the aid of the town's \$300,000 in American Rescue Plan Act funds
- Supported Ntera's application continuing effort to bring broadband to the northeast area of the town
- Implemented a program to create needed cul-de-sacs/turnarounds on dead-end roads in the town with three projects now underway
- Supported Fire Department's successful effort to obtain \$154,400 in funding through the State of Wisconsin Department of Health's 2023 Emergency Service Flex Grant program
- Board approval and purchase of 2 more electronic poll books (Badger Books) town will now have five Badger Books, to handle in person voting for 2024.
- Treasurer requested from the Board and was approved to do online transferring for funds for Town of Eagle Point Accounts. Created efficiency for bill paying, and when board approved, transfers from accounts for purchases.
- Treasurer submitted to the Board, request for portion of general money market. Town Equipment money market, Fire Department money market, Fire Department Donation money market into Certificates of Deposit for six months, for accounts totaling over \$900,000. This will result in over \$20,000 in interest revenue for the town.
- Purchased 1.6-acre parcel adjacent to town property and north of the Cold Storage Building
- The Town's Facebook (social media) page has increased communication and connectedness within the community. The page's followers increased by over 130 users since early 2022 (total currently at 246). A recent post had a total of reach of over 2,000.
- The Recycling Center implemented a plan for being open additional days in the spring for brush and yard cleanup.
 - Completed town hall air-conditioning project with donations and budgeted town funds
