Buoy 5 - 44°58'40.4"N 91°20'28.6"W Buoy 6 - 44°58'38.3"N 91°20'28.7"W

Twelve (12) placard signs reading SLOW-NO-WAKE, with 3 signs attached to each side of the Old Abe Trail Bridge, placed near the 2nd, 4th and 6th bridge supports, and 3 signs attached to each side of the County Hwy S Bridge, placed near each of the three bridge supports.
